JUDGMENT

The Motion for Summary Judgment brought by the Plaintiff, Town of Angelo, came on for hearing on January 26, 2022 before the Honorable Richard A. Radcliffe, the Town of Angelo appearing in person by Board Member Jim Leverich and Attorney James A. Quartemont, and the Defendant, Blooming Ministries, Inc. appearing by telephone by Attorney Carla Smith; the Court having reviewed the files and pleadings in this matter and being fully advised in the matter, having found that there is no material facts in dispute, and for the reasons as stated on the record,

IT IS HEREBY ORDERED AND ADJUDGED:

1. There is no reasonable basis to believe that the Defendant, Blooming Ministries, Inc. would be able to abate its nuisances of junk vehicles and mobile homes prohibited by Town of Angelo Ordinance No. 97-12-9, therefore, the Town of Angelo is permitted to immediately abate said nuisance violations located upon the real property located at 15646 Hat Avenue, being Tax Parcel ID # 004-00531-2500 and legally described

as follows:

Lot 40 of a Certified Survey Map recorded in Volume 6 of CSM, page 61, located in the SW1/4 of the NE1/4, of Section 24, Township 17 North, Range 03 West, Town of Angelo, Monroe County, Wisconsin.

- 2. A Writ of Assistance shall issue directing the Monroe County Sheriff's Department to assist and supervise the Town's abatement.
- 3. The Town of Angelo's future costs incurred in the abatement may be assessed against the property as a special charge.
- 4. Blooming Ministries, Inc. is found guilty of its violation of the Town of Angelo Ordinance No. 97-12-9 and a civil forfeiture of \$7,900.00, being a fine of \$50.00 per day for a total of 158 days, is hereby imposed upon said Defendant, and said fee, if not paid, may be assessed as a special charge against the property.
- 5. The Town of Angelo's reasonable attorney's fees and costs in the total amount of \$4,841.62, which have been incurred in the prosecution of this action, if not paid, may be assessed as a special charge against the property.
